

## J O Combs Unified School District No. 44 ARIZONA STATE TAX CREDIT CONTRIBUTION FORM

Arizona Revised Statute 43-1089.01 provides that an individual may make a **non-refundable** contribution or pay certain fees to a public school for support of **qualified activities or programs**. The credit is equal to the amount contributed or fees paid. However, a single taxpayer credit cannot exceed \$200. For married taxpayers filing jointly, the credit cannot exceed \$400.
